b If property abuts a residential district, side or rear setbacks for principal buildings in abutting residential district may apply. In no case shall it be less than 10 feet.

c Side yards abutting a railroad right-of-way or a storm water drainage channel of at least 20 feet wide may be reduced to 15 feet.

M-1 Manufacturing District

The M-1 Manufacturing District is intended to provide for manufacturing, industrial, and related uses of a limited nature and size, which on the basis of actual physical and operational characteristics would not be detrimental to the surrounding area or to the City as a whole by reason of smoke, noise, dust, odor, traffic, physical appearance, or other similar factors.

n Asphalt and concrete plants
n Automobile and truck engine and body repair
n Building restoration contractor
n Candy and confectionery products
n Car wash facilities
n Chemicals
n Commercial service facilities, such as restaurants, financial institutions, and clinics
n Contractor's offices, shops, and yards with outdoor storage
n Environmental contractor

n Food processing and locker plants (no slaughterhouses)
n Freight yards, freight terminals, and transshipment depots

Permitted Accessory Uses*

n Garages used for storage of business vehicles
n Off-street parking and loading areas
n Office, storage, power supply, and other uses normally auxiliary to the principal industrial operation
n Residential quarters for the owner or caretaker; only one such dwelling unit on an industrial site
n Ground-mounted and building-mounted earth station dish and terrestrial antennas
n Solar collectors
n Retail sales of products produced on the premises
